Trustee Wetzel introduced the minutes of the October 7, 2024, Regular Meeting; October 15, 2024, Special Meeting; October 31, 2024, Special Meeting; and asked if there were any requested changes. With no changes being requested, Trustee Pieper moved to dispense with the reading of the minutes and approve the minutes as presented. Trustee Fry seconded the motion and with no further discussion, the motion was approved via unanimous roll call vote.

Fiscal Officer Report

Fiscal Officer Jesenko presented two Then and Now Purchase Orders, one for Crossroads Community Planning and the other to Monroe Township Fire Department.

Mr. Pieper will provide more information for the December Trustee meeting.
