**WHEREAS**, the Board owns certain township personal property in the form of: one (1) used 1987 CASE 885 Tractor with ditcher attachment; one (1) used LANDA Heated Power Washer; two (2) used overhead garage door openers; one (1) used 250 gallon oil tank (steel); and one (1) used 250 gallon fuel tank (steel); and,

**WHEREAS**, the Board, pursuant to R.C. 505.10, is authorized to dispose of township personal property that is no longer needed for public use, is obsolete, or is unfit for the purpose for which it was acquired.

**Section 1.** That the Board of Jersey Township Trustees hereby determines that the following township personal property is no longer needed for public use, is obsolete, or is unfit for the purpose for which it was acquired: one (1) used 1987 CASE 885 Tractor with ditcher attachment; one (1) used LANDA Heated Power Washer; two (2) used overhead garage door openers; one (1) used 250 gallon oil tank (steel); and one (1) used 250 gallon fuel tank (steel).

**Section 2.** That the Board, pursuant to R.C. 505.10 (D), shall place the above referenced personal property up for auction on the Internet auction established previously by Township Resolution No. 24-01-03-\_\_\_, adopted on January 3, 2024.

**Section 3.** It is found and determined that all formal actions of this Board concerning and pertaining to the adoption of this Resolution were taken in an open meeting of this Board, and that all deliberations of the Board, and any of its committees, that resulted in such formal action were in meetings open to the public, in accordance with all legal requirements including Ohio Revised Code §121.22.

**Section 4.** This Resolution shall take effect at the earliest time provided by law.
