**RESOLUTION TO ADOPT WITH MODIFICATIONS THE RECOMMENDATION OF
THE JERSEY TOWNSHIP ZONING COMMISSION AN AMENDMENT TO THE
JERSEY TOWNSHIP ZONING RESOLUTION AND CREATE
SECTION 16.36 "FOOD TRUCKS"**

The Board of Trustees of Jersey Township, Licking County, Ohio met in a regular meeting on May 1, 2023 at 1481 Mink Street, Pataskala, Ohio 43062, with the following members present:

Trustee Wetzels moved the following:

WHEREAS, on January 25, 2023, the Jersey Township Zoning Commission initiated a Zoning Resolution Text Amendment (the "Amendment") to permit Food Trucks as Section 16.36; and

WHEREAS, the Licking County Planning Commission reviewed and made a recommendation related to the Amendment on February 27, 2023; and

WHEREAS, the Zoning Commission reviewed and made a recommendation related to the Amendment on March 8, 2023; and

WHEREAS, on April 3, 2023, the Board of Township Trustees of Jersey Township (the "Board") received the recommendation from the Zoning Commission regarding the Amendment; and

WHEREAS, on April 3, 2023, the Board set the date and time for the hearing as May 1, 2023 at 7:30p.m. and ordered the publication of notice of the hearing in the newspaper of general circulation in the township; and

WHEREAS, notice of the Trustees' hearing was published in the Newark Advocate on April 20, 2023; and

WHEREAS, the Board held a hearing regarding the Amendment on May 1, 2023.

NOW, THEREFORE, BE IT RESOLVED, BY THE BOARD OF TRUSTEES OF JERSEY TOWNSHIP, LICKING COUNTY, OHIO, THAT THE FOLLOWING RESOLUTION BE AND IT HEREBY IS ADOPTED:

Section 1. That the Board adopts the recommendation of the Zoning Commission as received on April 3, 2023.

Section 2. That the Zoning Inspector is authorized and directed to cause the Jersey Township Zoning Resolution to be amended to reflect the text amendment.

Section 3. It is found and determined that all formal actions of this Board concerning and pertaining to the adoption of this Resolution were taken in an open meeting of this Board, and that all deliberations of the Board, and any of its committees, that resulted in such formal action were in meetings open to the public, in accordance with all legal requirements including Ohio Revised Code §121.22.


Section 4. This Resolution shall take effect at the earliest time provided by law.


