RESOLUTION TO ADOPT AN UPDATED COMPREHENSIVE PLAN

The Board of Trustees of Jersey Township, Licking County, Ohio met in a regular meeting on May 1, 2023 at 1481 Mink Street, Pataskala, Ohio 43062, with the following members present:

Trustee Wetzel moved the following:

WHEREAS, Jersey Township last updated its Comprehensive Plan document in 2010; and

WHEREAS, the Board of Township Trustees of Jersey Township (the "Board") initiated a Comprehensive Plan update in early 2022; and

WHEREAS, multiple meetings were held, involving residents, business owners, and technical agencies, as well as, two survey were conducted; and

WHEREAS, the Board has received a final draft of an updated Comprehensive Plan, including review and comments from the Jersey Township Zoning Commission; and

WHEREAS, the Board desires to update the Jersey Township Comprehensive Plan.

NOW, THEREFORE, BE IT RESOLVED, BY THE BOARD OF TRUSTEES OF JERSEY TOWNSHIP, LICKING COUNTY, OHIO, THAT THE FOLLOWING RESOLUTION BE AND IT HEREBY IS ADOPTED:

Section 1. That the Board adopts the Comprehensive Plan “Jersey 2035 – Embracing The Past – Planning For The Future” in its final form dated May 1, 2023.

Section 2. It is found and determined that all formal actions of this Board concerning and pertaining to the adoption of this Resolution were taken in an open meeting of this Board, and that all deliberations of the Board, and any of its committees, that resulted in such formal action were in meetings open to the public, in accordance with all legal requirements including Ohio Revised Code §121.22.


Section 3. This Resolution shall take effect at the earliest time provided by law.

The motion carried and the Resolution was adopted.


