## RESOLUTION TO ADOPT WITH MODIFICATIONS THE RECOMMENDATION OF THE JERSEY TOWNSHIP ZONING COMMISSION REGARDING AN AMENDMENT TO THE JERSEY TOWNSHIP ZONING RESOLUTION AND MAP

WHEREAS, on or about April 5, 2024, Jersey Township received an application submitted by Matt Martin to rezone a 1.69 acre parcel located at 9897 Jersey Mill Road (Parcel #036-110538-00.006) from RR to PUD (the "Original Application") attached hereto as "Exhibit A"; and

WHEREAS, on April 22, 2024, the Licking County Planning Commission reviewed the Original Application and provided a recommendation (the "LCPC Report") to the Jersey Township Zoning Commission, attached hereto as "Exhibit B"; and

WHEREAS, the Township's Planning and Zoning Consultant provided recommended revisions to the Jersey Township Zoning Commission regarding the Original Application on May 20, 2024, attached hereto as "Exhibit C"; and

**WHEREAS**, the Jersey Township Zoning Commission held a public hearing on May 8, 2024 and May 22, 2024 to review the Original Application, the LCPC Report, and "Exhibit C"; and

WHEREAS, the Jersey Township Zoning Commission made a recommendation to the Jersey Township Trustees at its May 22, 2024 meeting regarding the Original Application, the LCPC Report, and Exhibit C, including revisions and modifications titled "As Recommended by Township Zoning Commission", attached hereto as "Exhibit D".

NOW, THEREFORE, BE IT RESOLVED, BY THE BOARD OF TRUSTEES OF JERSEY TOWNSHIP, LICKING COUNTY, OHIO, THAT THE FOLLOWING RESOLUTION BE AND IT HEREBY IS ADOPTED:
