RESOLUTION APPROVING THE RENEWAL OF A HEALTH INSURANCE PLAN THROUGH WAYPOINT BENEFIT SOLUTIONS FOR CALENDAR YEAR 2025 AND AUTHORIZING PAYMENT OF PREMIUMS

The Board of Trustees of Jersey Township, Licking County, Ohio met in a regular meeting on December 26, 2024 at 1481 Mink Street, Pataskala, Ohio 43062, with the following members present:

Trustee Wetzel moved the following:

WHEREAS, the Board of Township Trustees of Jersey Township (the "Board") has dental, vision, and received health insurance premiums quotes for calendar year 2025; and

WHEREAS, the Board has elected to change from its existing HRA plan to an HSA plan; and

WHEREAS, the Board desires to proceed with the renewal of dental, vision, and health insurance benefits through Waypoint Benefit Solutions.

NOW, THEREFORE, BE IT RESOLVED, BY THE BOARD OF TRUSTEES OF JERSEY TOWNSHIP, LICKING COUNTY, OHIO, THAT THE FOLLOWING RESOLUTION BE AND IT HEREBY IS ADOPTED:

- **Section 1.** The Board authorizes the renewal of dental, vision, and health insurance (Option #4 of the attached "Medical Benefits Comparison") benefits through Waypoint Benefit Solutions, with township coverage of 100% of the employee maximum out-of-pocket or amount otherwise allowed by law.
- Section 2. The Board authorizes and directs the Fiscal Officer to fund the costs of premiums, HSA accounts, and related insurance benefits.
- **Section 3.** The Board authorizes Waypoint Benefit Solutions, through June 30, 2025, to fund employee HRA requests dated January 1, 2023 December 31, 2024 under the previous HRA plan.
- **Section 4.** It is found and determined that all formal actions of this Board concerning and pertaining to the adoption of this Resolution were taken in an open meeting of this Board, and that all deliberations of the Board, and any of its committees, that resulted in such formal action were in meetings open to the public, in accordance with all legal requirements including Ohio Revised Code §121.22.
- Section 5. This Resolution shall take effect at the earliest time provided by law.
